### June 2022 CFP® Certification Examinations Results Release

(Hong Kong – 27 July, 2022) The Institute of Financial Planners of Hong Kong (IFPHK) announced today the results of the June 2022 CFP Certification Examination (Foundation Level), CFP Certification Examination (Advanced Level Paper 1) and CFP Certification Examination (Advanced Level Paper 2) held on 18 June, 2022 in Hong Kong and Macau.

Examinees' background and their performance are summarized below:

#### June 2022 CFP Certification Examinations

<b>Pass Rate</b>	The CFP certification examination (Foundation Level) recorded a pass rate of 70.53% while 51.67% of examinees passed the CFP certification examination (Advanced Level Paper 1) and 51.09% of examinees passed the CFP certification exam (Advanced Level Paper 2).
<b>Meritor</b>	18 examinees have attained Merit status in CFP certification examination (Foundation Level). For both CFP Certification Examination (Advanced Level Paper 1) and CFP Certification Examination (Advanced Level Paper 2), there were one examinee awarded with Top Scorer status.
<b>Education Level</b>	Approximately 83% of the total examinees possess a Bachelor's Degree or above.
<b>Industry Background</b>	Of the three examinations, around 88.26% of the examinees are employees of banking, insurance and independent financial advisory sectors.
<b>Age</b>	Around 70.85% of the total examinees are between 20 and 39 years old.
