IFPHK Financial Education and ESG Leadership Awards Cum Accredited Professional Financial Planning Firm 2022 19 Companies Accoladed for Financial Excellence

(Hong Kong – 6 December, 2022) Organized by the Institute of Financial Planners of Hong Kong (IFPHK), the "IFPHK Financial Education and ESG Leadership Awards cum Accredited Professional Financial Planning Firm 2022" Awards Presentation Ceremony took place at Conrad Hong Kong earlier (29 November). Over 100 prestigious guests from the government, regulatory, industry and nonprofit making sectors were seen at the occasion to celebrate collective effort in pro bono financial education. In its fifth year of making, 19 companies were accoladed, with China Life Insurance (Overseas) Company Limited and FWD Life Insurance Company (Bermuda) Limited crowned the highest honor "Best Corporate Financial Education and ESG Leadership of the Year".

The Ceremony was honored to have Mr. Joseph Chan, JP, Under Secretary of Financial Services and the Treasury, HKSAR as the Guest-of-Honor. Ms. Ginni Wong, Director (Supervision) of the Mandatory Provident Fund Schemes Authority and Mr. Andrew Wan, Chief Financial Officer of Securities and Futures Commission also graced the ceremony as presenters.

Mr. Chris Tse, Chairman of IFPHK, commenced with a welcome speech. He highlighted that the with both Awards stepping into its fifth year and tenth year, it has become a significant platform where companies can made themselves known to the public in their financial education and financial planning excellence. 
About IFPHK


