December 2023 CFP® Certification Examinations Results Release

(Hong Kong – 25 January, 2024) The Institute of Financial Planners of Hong Kong (IFPHK) announced today the results of the December 2023 CFP Certification Examination (Foundation Level), CFP Certification Examination (Advanced Level Paper 1) and CFP Certification Examination (Advanced Level Paper 2) held on 16 December, 2023 in Hong Kong and Macau.

Examinees' background and their performance are summarized below:

December 2023 CFP Certification Examinations

Pass Rate	The CFP certification examination (Foundation Level) recorded a pass rate of 71.43% while 48.08% of examinees passed the CFP certification examination (Advanced Level Paper 1) and 72.60% of examinees passed the CFP certification exam (Advanced Level Paper 2).
Meritor	10 examinees have attained Merit status in CFP certification examination (Foundation Level). For both CFP Certification Examination (Advanced Level Paper 1) and CFP Certification Examination (Advanced Level Paper 2), there were 3 examinees awarded with Top Scorer status.
Education Level	Approximately 89.36% of the total examinees possess a Bachelor's Degree or
	above.
Industry	Of the three examinations, around 71.81% of the examinees are employees of
Background	banking, insurance and independent financial advisory sectors.
Age	Around 64.89% of the total examinees are between 20 and 39 years old.
